Introduction:

Gender-responsive budgeting enables the inclusion of gender considerations throughout the process of formulating legislation, policies, and programs, including resource allocation and collection. This approach extends to implementation, execution, and follow-up actions, all aimed at addressing gender disparities. Thus, incorporating a gender perspective into legislative formulation is essential for achieving desired outcomes and minimizing gender gaps.

Given this context, Arun Jaitley National Institute of Financial Management Organised a twoday workshop at Anna University, Chennai in collaboration with the State Government, Tamil Nadu to catalyze discussions, deliberations, and the development of a concrete action plan to address challenges and constraints. The aim was to enhance capacity and training with a specific focus on addressing gender-related concerns.

Significance of Gender-Based Budgeting:

- GBB helps identify and address specific needs and priorities of women, men, and other gender groups within the municipality, thereby reducing gender disparities in access to resources and services.
- By mainstreaming gender considerations into budget processes, GBB contributes to promoting gender equality and empowering women by allocating resources for initiatives such as women's education, health, livelihoods, and safety.
- GBB increases transparency and accountability in municipal budgeting by disaggregating budget data by gender, enabling stakeholders to track resource allocations and expenditures related to gender-specific programs and services.
- Incorporating gender perspectives into municipal budgets fosters more inclusive decisionmaking processes, leading to better governance outcomes and improved service delivery for all residents, regardless of gender.



Theme of the Workshop

The theme of the State-level workshop on Gender-Responsive Budgeting could be "Empowering Communities: Advancing Gender Equality through Inclusive Budgeting".

This theme reflects the workshop's focus on utilizing budgeting processes at the State level as a means to promote gender equality and empower marginalized groups within the community. It underscores the importance of incorporating gender considerations into budgetary decisions to address disparities and ensure that the needs and priorities of all genders are adequately met.

Objectives of the Gender Responsive workshop at State level:

- 1. To increase understanding among participants about the concept of gender-responsive budgeting and its significance in promoting gender equality and social inclusion.
- 2. To analyse budgets through a gender lens, identify gender-specific needs and priorities, and advocate for gender-responsive policies and resource allocations.

Topic: Gender Responsive Budgeting and Gender Equality: An Overview **Speaker:** Ms. Vandana Jena, Ex-Secretary, Dept. of Land Resources, Ministry of Rural Development and Ex-Principal Advisor, Planning Commission of India.

The first technical session was chaired by Ms. Vandana Jena who conducted an interactive session on the concept of gender-based budgeting and present status of gender budgeting in the country.

Gender Responsive Budgeting (GRB) is an approach used by governments to promote gender equality through their budgetary processes. It involves analyzing how budget allocations and expenditures impact men and women differently and ensuring that public resources are distributed fairly to address gender disparities and promote equality.

Here's an overview of Gender Responsive Budgeting and its relationship with gender equality:

- 1. Gender equality refers to the equal rights, responsibilities, and opportunities of all individuals, regardless of their gender. It involves eliminating discrimination based on gender and ensuring that both men and women have access to the same resources and opportunities in all aspects of life, including education, employment, healthcare, and political participation.
- 2. The primary purpose of GRB is to integrate gender perspectives into budgetary processes to advance gender equality goals. It aims to identify and address gender disparities in resource allocation and expenditure, ultimately leading to more equitable outcomes for men and women.
- 3. GRB involves examining government budgets to understand how they impact men and women differently. This analysis includes identifying areas where resources are allocated disproportionately to one gender or where budgetary decisions perpetuate gender-based inequalities. It also assesses whether budget allocations support programs and services that address the specific needs and priorities of different genders.
- 4. GRB typically consists of several key components, including gender analysis of budgets, gender mainstreaming in budget policies and processes, gender-sensitive indicators and targets, and mechanisms for monitoring and evaluating the gender impacts of budgetary decisions.
- 5. By integrating gender perspectives into budgeting processes, GRB can lead to more effective and efficient use of resources. It helps governments prioritize investments in areas that promote gender equality, such as education, healthcare, and social protection programs. Additionally, GRB can enhance transparency and accountability in budgetary decisions, as it requires governments to justify their resource allocations based on gender considerations.
- 6. Implementing GRB can be challenging due to various factors, including limited capacity and expertise in gender analysis, resistance to change within government institutions, and lack of political will. Additionally, measuring the impact of GRB initiatives on gender equality outcomes can be complex and may require long-term monitoring and evaluation efforts.
- 7. Many countries around the world have adopted GRB as part of their efforts to promote gender equality. For example, countries like Sweden, South Africa, and the Philippines have implemented GRB initiatives with varying degrees of success. International organizations such as the United Nations and the World Bank also support GRB efforts through capacity-building initiatives and technical assistance.

In summary, Gender Responsive Budgeting is a critical tool for advancing gender equality by ensuring that government budgets are designed and implemented in ways that address the needs and priorities of both men and women. By integrating gender perspectives into budgetary processes, GRB can help create more equitable societies where all individuals have equal opportunities to thrive.

Topic: Understanding Gender budgeting: Emerging Regional, National and Global perspective

Speaker: Dr B.K. Pandey, Professor of Practice, AJNIFM.

Analyzing gender budgeting through these lenses provides a holistic understanding of its significance in advancing gender equality and inclusive development agendas on multiple scales.

Topic: Mechanisms for operationalizing Gender Budgeting and the Budget Cycle and Gender Budgeting

Speaker: Shri Satyen Lama, Professor, Arun Jaitley National Institute of Financial Management

The Second technical session was taken by Shri Satyen Lama who discussed the Context and Pre-requisites, Institutional Mechanisms & Practices and Tools for Deepening Gender Budgeting. The following were the issues covered:

- 1. **Context**: In this regard it was explained how Gender Budgeting is a tool for Gender Mainstreaming, how it can be It used as an entry point to apply a gender lens to the entire policy spectrum and why Gender Budgeting is not confined to the budget document but includes a series of processes that precede the preparation of the budget as well as that follow it.
- 2. **Pre-Requisites**: In this regard the participants were helped to understand gender equality and gender issues, the contribution that the Ministry/Department can make to achieving the National Goal of Gender Equality, the concept and tools of Gender Budgeting and how Sex-disaggregated data can enable analysis of the situation of women and girls as well as men and boys in each sector
- 3. **Institutional Mechanisms & Practices**: In this regard the participants were helped to understand Gender Aware Policy Appraisal, Gender Budget Statement, Outcome Budget, the Results Framework Document (RFD) and its practical examples.
- 4. **Tools for Deepening Gender Budgeting**: The Five Step Framework for Gender Budgeting, Participatory planning and budgeting, spatial mapping, Using Gender-sensitive Checklists I & II (including planning and budgeting, performance audit, future planning and corrective action).

Topic: Tamil Nadu pathways to Gender Budgeting

Topic: The influencing factors and missing links of Gender Budgeting **Speaker:** Ms. L. Suganthi, Dean (CEG), Anna University

Madam Suganthi in her lecture mentioned that Gender budgeting is influenced by various factors, and there are several missing links that can impact its effectiveness. She described some of the important influencing factors and missing links:

Influencing Factors:

1. The commitment of political leaders and policymakers to gender equality and women's empowerment significantly influences the implementation of gender budgeting. Strong

political will is essential for allocating adequate resources and implementing genderresponsive policies and programs.

- 2. Availability and quality of gender-disaggregated data are crucial for conducting gender analysis and informing budgetary decisions. Access to reliable data on gender disparities, needs, and priorities helps in designing targeted interventions and monitoring their impact.
- 3. The capacity and expertise of government officials, policymakers, and stakeholders in understanding gender issues and implementing gender-responsive budgeting play a vital role. Training and capacity-building programs are necessary to enhance their skills and knowledge in this area.
- 4. The active involvement of civil society organizations, women's groups, and marginalized communities can influence gender budgeting by advocating for gender-sensitive policies, monitoring budget implementation, and holding governments accountable.
- 5. The existence of legal frameworks and policies that promote gender equality and women's rights provides a supportive environment for gender budgeting. Laws and regulations mandating gender mainstreaming in budget processes can facilitate its implementation.

Missing Links

- 1. Despite efforts to incorporate gender considerations into budgeting, there may be inadequate gender analysis, leading to a lack of understanding of how budget allocations impact different gender groups.
- 2. Insufficient allocation of resources for gender equality initiatives can hinder the implementation of gender budgeting. Without adequate funding, it may not be possible to address the diverse needs and priorities of women and marginalized gender groups.
- 3. Fragmentation and siloed approaches within government departments and agencies can undermine the effectiveness of gender budgeting. Coordination and collaboration across sectors are necessary to ensure a holistic and integrated approach to gender equality.
- 4. The absence of robust monitoring and evaluation mechanisms can make it challenging to assess the impact of gender budgeting initiatives accurately. Without proper evaluation, it may be difficult to identify successes, challenges, and areas for improvement.
- 5. Resistance to change within government institutions and bureaucratic structures can impede the mainstreaming of gender considerations in budget processes. Overcoming resistance and promoting a gender-responsive culture requires sustained advocacy and leadership.

Addressing these missing links requires concerted efforts from governments, civil society, and other stakeholders to strengthen the implementation of gender budgeting and advance gender equality and women's empowerment. This includes improving data collection and analysis, increasing resource allocation for gender equality initiatives, fostering collaboration and coordination, enhancing monitoring and evaluation mechanisms, and promoting a supportive policy environment for gender-responsive budgeting.

Topic: Analysis & Implementation of Schemes in Tamil Nadu through Gender lens **Speaker:** Ms. Shilu Francis, President, Tamil Nadu Women Collective
